# **Baseline Emissions Footprint**

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

#### Baseline Year: 2019

Additional Details relating to the Baseline Emissions calculations.

Our baseline reporting year is 2019. Scope 1 includes emissions from our company vehicles and Natural Gas emissions to heat our premises. Scope 2 emissions include Electricity used to light and power our office and warehouse. Scope 3 sources included Business Travel by air and Hotel stays.

# **Current Emissions Reporting**

#### Reporting Year: 2022

Our 2022 report showed a marked decrease in Scope 1 & 2 emissions due to the completion of energy saving initiatives undertaken in 2021 & 2022. Our Scope 1 emissions were reduced as our petrol and diesel vehicles were replaced with Hybrid and EV's. Our new gas boiler to heat our premises is more efficient and we installed loft insulation which reduced our emissions from Natural Gas use. Scope 2 emissions also reduced as we replaced fluorescent tube lighting with LED units. This reduction was despite charging some Electric Vehicles at our head office location. Scope 3 emissions for this year included Business Travel by Air and Hotel stays. Scope 3 also showed a reduction from our baseline year although not as a result of any carbon reduction initiatives.



## **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **67 tCO2e** by 2027. This is a reduction of **15%**

# **Carbon Reduction Projects**

### **Completed Carbon Reduction Initiatives**

BVM Medical have completed the following environmental management measures and projects since the 2019 baseline. These initiatives have reduced our Scope 1 and 2 carbon emissions by **7.13 tCO<sub>2</sub>e**, a **18.55%** reduction against the 2019 baseline and the measures will be in effect when performing the contract.

- 1. Replacement of fifteen Petrol/Diesel vehicles with Hybrid/EV's
- 2. Installation of Loft insulation at our head office premises
- 3. Implementation of ISO14001:2015 Environmental Management System
- 4. Replacement of Gas Boiler and installation of new heating controls
- 5. Replacement of Fluorescent Tube lighting with LEDs throughout our offices.

In the future we hope to implement further measures such as:

- 1. Installation of Solar Panels at our head office premises.
- 2. Increased use of Rail Travel
- 3. Future replacement of Hybrid Vehicles with EV's with improvements to external infrastructure

## **Declaration and Sign Off**

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
